Modi hails US congressional delegation for India support

New Delhi, Nov 14: Prime Minister Narendra Modi held a meeting with a delegation of US lawmakers on Saturday, during which he appreciated the consistent support and constructive role of the US Congress in deepening the India-US comprehensive global strategic partnership anchored in shared democratic values.

In a statement, the Prime Minister's Office (PMO) said the US congressional delegation was led by Senator John Cornyn and included senators Michael Crapo, Thomas Tuberville and Michael Lee, and Congress members Tony Gonzales and John Kevin Elizey.

Cornyn is the co-founder and co-chair of the Senate Caucus on India and Indian Americans.

"The congressional delegation noted the excellent management of the Covid situation in India despite the challenges of large and diverse population. The prime minister noted people's participation based on the country's democratic ethos played a key role in managing the worst pandemic of the last one century," the PMO said.

There was a warm and frank discussion on regional issues of mutual interests, including those related to South Asia and the Indo-Pacific region, it added.

Modi and the visiting delegation took note of the increasing convergence of strategic interests between the two strategic partners and expressed their desire to further enhance cooperation with

an aim to promote global peace and stability.

Modi later tweeted, "Met a US Congressional delegation led by Senator @JohnCornyn and consisting of Senators @MikeCrapo, @SenTuberville, @SenMikeLee and Congressmen @RepTonyGonzales, @RepElizey. Appreciated the support and constructive role of the US Congress for deepening the India-US partnership." Views were also exchanged on the potential for enhancing the bilateral relationship and strengthening cooperation on contemporary global issues such as terrorism, climate change and reliable supply chains for critical technologies, the PMO said.

Japan's princess gives up throne, leaves for US

Tokyo, Nov 14: A Japanese princess who gave up the throne to marry her commoner college sweetheart left for New York on Sunday, as the couple pursued happiness as newlyweds and left behind a nation that has criticised their romance.

The departure of Mako Komuro, the former Princess Mako, and Kei Komuro, both 30, as they boarded their plane amid a flurry of camera flashes at Haneda airport in Tokyo was carried live by major Japanese broadcasters.

Kei Komuro, a graduate of Fordham University law school, has a job at a New York law firm.

He has yet to pass his bar exam, another piece of news that local media have used to attack him, although it is common to pass after multiple attempts.

I love Mako, he told reporters last month after registering their marriage in Tokyo. They did so without a wedding banquet or any of the other usual celebratory rituals.

I want to live the

only life I have with the person I love, he said.

Although Japan appears modern in many ways, values about family relations and the status of women remain somewhat antiquated, rooted in feudal practices.

Such views were accentuated in the public's reaction to the marriage. Some Japanese feel they have a say in such matters because taxpayer money supports the imperial family system.

Maharashtra transport staff attempts suicide

Palghar, Nov 14:

A 30-year-old MSRTC employee, who had been on strike along with other transport corporation workers, allegedly tried to commit suicide at his home here in Maharashtra, police said today.

A section of employees of the Maharashtra State Road Transport Corporation (MSRTC) have been on strike since last month, demanding that the cash-strapped corporation be merged with the state government, so that they get the status and benefits of government employees.

On Saturday evening, driver Deepak Khorgade, employed at the MSRTC's Jawhar depot in Palghar, allegedly consumed poison at his home, a police official said.
